### 1. INTRODUCTION

- 1.1 This information manual is compiled in accordance with the Promotion of Access to Information Act, 2000 ("PAIA" or the "Act") which gives effect to section 32 of the Constitution and provides that everyone has a right to access information held by the State or private bodies when that information is required for the exercise or protection of any rights. This manual provides an outline of the types of records held by Purple Group Limited ("Purple") and its subsidiaries, EasyProperties is a subsidiary of the Purple and forms part of the Purple group of companies. This manual also explains how one may submit requests for access to these records in terms of the Act. Requesters are referred to the guide in terms of section 10 of the PAIA Act which is available from the South African Human Rights Commission ("SAHRC") website: www.sahrc.org.za.

- 2. **DEFINITIONS**
- 2.1 PAIA means the Promotion of Access to Information Act 2 of 2000.
- POPI means the Promotion of Personal Information Act 4 of 2013. 2.2
- 2.3 Information Regulator means the Regulator established in terms of Section 39 of POPI.
- 2.4 **Person** means a natural person or a juristic person.
- 2.5 Private body means:
  - a natural person who carries or has carried on any trade, business or profession, but only in such capacity (1)
  - (2)a partnership which carries or has carried on any trade, business or profession; or
  - (3)any former or existing juristic person, but excludes a public body.
- 2.6 Public body means:
  - any department of state or administration in the national or provincial sphere of government or any municipality in the (1) local sphere of government; or
  - (2)any other functionary or institution when:
    - exercising a power or performing a duty in terms of the Constitution or a provincial constitution; or (a)
    - (b) exercising a public power or performing a public function in terms of any legislation.
- 2.7 **Head**, in relation to, a private body means:
  - (1) in the case of a natural person, that natural person or any person duly authorised by that natural person;
  - (2)in the case of a partnership, any partner of the partnership or any person duly authorised by the partnership;
  - (3)in the case of a juristic person:
    - the chief executive officer or equivalent officer of the juristic person or any person duly authorised by (a) that officer: or
    - (b) the person who is acting as such or any person duly authorised by such acting person.
- **Information Officer** means the head of a private body. 2.8
- Deputy Information Officer means the person to whom any power or duty conferred or imposed on an Information Officer by 2.9 POPI has been delegated.
- 2.10 Requester in relation to a private body, means any person, including, but not limited to public body or an official thereof, making a request for access to a record of the organisation or a person acting on behalf of such person
- Personal Requester means a requester seeking access to a record containing personal information about the requester 2 11
- 2.12 Personal Information means information relating to an identifiable, living, natural person, and where it is applicable, an identifiable, existing juristic person, including, but not limited to: information relating to the race, gender, sex, pregnancy, marital status, national, ethnic or social origin, colour, sexual orientation, age, physical or mental health, well-being, disability, religion, conscience, belief, culture, language and birth of the person; information relating to the education or the medical, financial, criminal

or employment history of the person; any identifying number, symbol, e-mail address, physical address, telephone number, location information, online identifier or other particular assignment to the person, the biometric information of the person; the personal opinions, views or preferences of the person; correspondence sent by the person that is implicitly or explicitly of a private or confidential nature or further correspondence that would reveal the contents of the original correspondence; the views or opinions of another individual about the person; and the name of the person if it appears with other personal information relating to the person or if the disclosure of the name itself would reveal information about the person.

- 2.13 Request for access means a request for access to a record of the organisation in terms of section 50 of PAIA.
- 2.14 **Record** means any recorded information regardless of the form or medium, in the possession or under the control of the organisation irrespective of whether or not it was created by the organisation.
- 2.15 **Data Subject** means the person to whom personal information relates.
- 2.16 **Third Party** in relation to a request for access to a record held by the organisation, means any person other than the requester.
- 2.17 **Processing** means any operation or activity or any set of operations, whether or not by automatic means, concerning personal information, including the collection, receipt, recording, organisation, collation, storage, updating or modification, retrieval,

### 6. STEPS TO CONSIDER BEFORE SUBMITTING A REQUEST

### 6.1 Are you entitled to use PAIA to request access?

Please take note of section 7(1) of the Act which states:

- (1) This Act does not apply to a record of a public body or a private body if—
  - (a) that record is requested for the purpose of criminal or civil proceedings;
  - (b) so requested after the commencement of such criminal or civil proceedings, as the case may be; and
  - (c) the production of or access to that record for the purpose referred to in paragraph (a) is provided for in any other law.

If section 7(1) applies, you may not bring a request in terms of PAIA. You must use the rules and procedures for discovery of information of the relevant legal forum and proceedings you are involved in. Purple and EasyProperties reserves the right to claim all expenses and other damages incurred as a result of a requester submitting a request in contravention of section 7(1).

### 6.2 Does the information requested exist in the form of a record?

Please note that PAIA only applies to records that are in existence at the time of us receiving your request. PAIA does not compel anyone to create a record which is not yet in existence at the time the request is made.

- 6.3 Is the record in the possession or under the control of Purple and/or EasyProperties?
- 6.4 PAIA provides that the record requested must be in our possession or under our control. Therefore, even if a record was created by Purple and/or EasyProperties or at some point in Purple and/or EasyProperties" possession (but no longer in Purple and/or

EasyProperties' control at the time of your request), you must seek access to the record from the party under whose possession or control it is.

### 7. PROCESS FOR REQUESTING INFORMATION

- 7.1 All clients are allowed to access their own information without having to go through this formal information request process.
- 7.2 Clients must send their request in writing, e.g. email
- 7.3 EasyProperties will verify the identity of the relevant client prior to providing the requested information.
- 7.4 All clients should contact Client Relations department to access their information.
- 7.5 This process may not be used to obtain information for the use in any legal action.
- 7.6 Records for legal action should be obtained using the rules and procedures for discovery of information that are defined for legal proceedings. EasyProperties has the right to claim all expenses and other damages that result from a request that breaks the abovementioned law.
- 7.7 The process only applies to records that exist at the time of the request for information. It does not require the company to create a record which does not exist at the time the request is made.
- 7.8 Provided that none of the restrictions mentioned above apply, any person wishing to access a record, in terms of the Act, that is not freely available, are required to file a request using the prescribed form (Annexure 1). The form may be obtained from the Information Officer or Compliance Officer at the contact details contained within this document. The completed form is to be submitted to the Information Officer together with the details of the authority to request the information and payment of any applicable request fees as prescribed in the fee structure below (Annexure 2).
- 7.9 A request made on behalf of another person should be accompanied by proof of the capacity or authority to request the information.
- 7.10 Failure to fully complete the prescribed form will result in delaying the process while the company requests further information

### 8. HOW TO SUBMIT A REQUEST FOR ACCESS

### 8.1 Request form:

Please complete the request form in Annexure 1 to this Manual and forward to the Information Officer, specified above. In the Request Form, you need to provide sufficient information to enable us to adequately identify –

- (1) The record or records requested;
- (2) The identity of the requester,
- (3) Which form of access is required, if the request is granted;
- (4) The postal address or fax number of the requester.

### 8.2 **Description of the right:**

The right which you are seeking to protect or enforce by means of the records requested must be adequately described. The courts have indicated that access to the records must be necessary for the exercise or protection of the right so stated. It is

important to note that Purple's Information Officer may refuse you access to the records requested if the right is not clearly defined or where the right you claim to seek to exercise or protect does not qualify as a right as contemplated in PAIA.

#### Representatives: 8.3

If a request is made on behalf of another person, then the requester must submit proof of the capacity in which the requester is making the request to the reasonable satisfaction of Purple's Information Officer.

#### Prescribed fee: 8.4

The prescribed access fee, if applicable, as provided for in Annexure 2 below must be paid and proof of payment must be submitted along with your request.

The Act provides for two types of fees, namely:

- (1) A request fee, which will be a standard fee; and
- (2)An access fee, which must be calculated by taking into account reproduction costs, search and preparation time and cost, as well as postal costs.

The requester, other than a personal requester, seeking access to a record containing personal information, must pay the prescribed R50.00 (fifty rand) request fee, before submitting the request and provide proof of payment which must accompany the Request Form.

If the search for and preparation of the record (for disclosure), including arrangement to make it available in the requested form, requires more than the hours prescribed in the regulations for this purpose, the information officer will request you to pay as a deposit the prescribed portion of the access fee which would be payable if the request is granted.

The Information Officer may withhold a record until the requester has paid the fees as indicated in Annexure 2.

A requester whose request has been granted must pay an access fee for reproduction and for search and preparation, and for any time reasonably required in excess of the prescribed hours to search for and prepare the record for disclosure including making arrangements to make it available in the Request Form.

You may ask for a refund of the deposit if your request for access is refused.

#### **CONSIDERING YOUR REQUEST** 9.

- Subject to the provisions in the Act in respect of extension of time periods, EasyProperties will process the request within 30 9.1 days, unless you have stated special reasons which would satisfy the Information Officer that circumstances dictate that the above time periods not be complied with.
- You will be informed in writing whether access has been granted or denied. 9.2
- 9.3 The main grounds for EasyProperties to refuse a request for information relate to the –
  - (1) mandatory protection of the privacy of a third party who is a natural person, which would involve the unreasonable disclosure of personal information of that natural person;
  - (2)mandatory protection of the commercial information of a third party, if the record contains -
    - (a) trade secrets of that third party;
    - (b) financial, commercial, scientific or technical information which disclosure could likely cause harm to the financial or commercial interests of that third party;

- (c) information disclosed in confidence by a third party to EasyProperties, if the disclosure could put that third party at a disadvantage in negotiations or commercial competition;
- (d) mandatory protection of confidential information of third parties if it is protected in terms of any agreement;
- (e) mandatory protection of the safety of individuals and the protection of property;
- (f) mandatory protection of records which would be regarded as privileged in legal proceedings;
- (g) the commercial activities of EasyProperties, which may include -
- (h) trade secrets of EasyProperties;
- (i) financial, commercial, scientific or technical information which disclosure could likely cause harm to the financial or commercial interests of EasyProperties;
- information which, if disclosed could put EasyProperties at a disadvantage in negotiations or commercial competition;
- (k) a computer program which is owned by EasyProperties, and which is protected by copyright.
- 9.4 The research information of EasyProperties or a third party, if its disclosure would disclose the identity of EasyProperties, the researcher or the subject matter of the research would place the research at a serious disadvantage.

### 10. YOUR REMEDIES

EasyProperties does not have internal appeal procedures. As such, the decision made by the Information Officer is final. If your request is denied, you are entitled to apply to a court with appropriate jurisdiction for relief.

  - e) For a transcription of an audio record
    - i. For an A4-size page or part thereof R20,00
    - ii. For a copy of an audio record R30,00
  - f) To search for and prepare the record for disclosure, R30.00 for each hour or part of an hour, excluding the first hour, reasonably required for such search and preparation
- 5. For purposes of section 54 (2) of the Act, the following applies:
  - Six hours as the hours to be exceeded before a deposit is payable; and
  - One third of the access fee is payable as a deposit by the requester
- 6. The actual postage is payable when a copy of a record must be posted to a requester
